Building Fee Schedule

Residential:

New construction, additions, Use Groups R-3 & R-4 (single family) \$40.00+0.17/sq. ft. gfa

Alterations & repairs: 1.25% of construction cost.

Utility & misc. use groups (sheds, decks, fences, pools, towers concrete slabs, retaining walls, etc. – 1.50% of construction cost.

All Use Groups other than R-3, R-4, utility and misc.: P

New construction & additions: \$60.00+0.25/sq. ft. gfa

Alterations: 2.5% of construction cost.

Demolition: \$50.00

Signs: \$25.00+\$2.00 sq. ft. of sign area.

Minimum fee: \$40.00

Driveways: \$40.00

Street opening permits: bond required.

Fourth & Fifth Avenues to 300 sq. ft.

\$150.00-\$1,110.00

Other improved streets to 300 sq. ft.

\$35.00 - \$555.00

Unimproved streets: \$150.00

Certificates of inspection are not required.

Zoning Variance: \$375.00

Occupancy permit is required: \$40.00

Sewer tap-in charge: \$7,000.00

Sewage disposal rates: \$8.27/1,000 gallons of water used (Borough of Coraopolis).

Sewer rate – 1,000 gallons: \$7.01
